#### PRIVACYVERKLARING & COOKIE STATEMENT



BSS Familierecht respects the privacy of its clients and visitors to its website www.bssfamilierecht.nl. In this statement, we explain how we handle your personal data and use cookies on our site.

#### What is personal data?

A personal data is any data that can identify a natural person, directly or indirectly. A personal data can be a name or phone number, but also a date of birth or IP address.

# Which personal data does BSS Familierecht process and why?

We process personal data that you have provided to us, for example when you have contacted us as a client, when you have signed up for a newsletter or meeting, when you have applied for a position at BSS Familierecht or when you use our services in another way.

We process your personal data only for the purpose for which we obtained it. Furthermore, we may use your personal data to send you newsletters, insofar as you appreciate that.

### How long does BSS Familierecht keep your personal data?

BSS Familierecht will not keep your personal data longer than strictly necessary to realize the purposes for which your data are collected. If and insofar as we are subject to a legal obligation to retain documents containing personal data, we will comply with the legal retention period.

## How do we guarantee your privacy?

Because we take the protection of your data seriously, we have taken appropriate measures to prevent loss, misuse. unauthorized access, unwanted disclosure and unauthorized modification.

We share your personal data with third parties only to the extent necessary to perform our work and to comply with certain legal obligations. We conclude а processor agreement with companies that process your data on our behalf to ensure the same of security level and confidentiality of your data.

Despite our efforts, do you have the impression that your personal data is not properly secured or do you have any indications of misuse thereof? The same data can be used if you do not wish to receive information about the services of BSS Familierecht (anymore).

### How can you view, modify or delete personal data?

You have the right to view, correct or delete your personal data. You also have

Your request will be processed and complied with within four weeks after receipt, to the extent reasonably possible in view of our legal (storage) obligations and the correct execution of the assignment(s) provided to BSS Familierecht.

Our website www.familierecht.nl uses cookies. Cookies are small text files that are stored on your PC, tablet or smart phone. They ensure that our website works properly and that we can further optimize it. We also use cookies to collect and analyze statistics, for social media integration and to serve targeted ads on social media.

We use cookies from Google Analytics to measure and analyze the use of our website. These cookies can never be directly traced back to individuals. Based on this data, we can further improve our website. Google also uses this data itself in accordance with its own terms and conditions. Please note that Google may change this information and does so regularly. BSS Familierecht has no influence on that.
